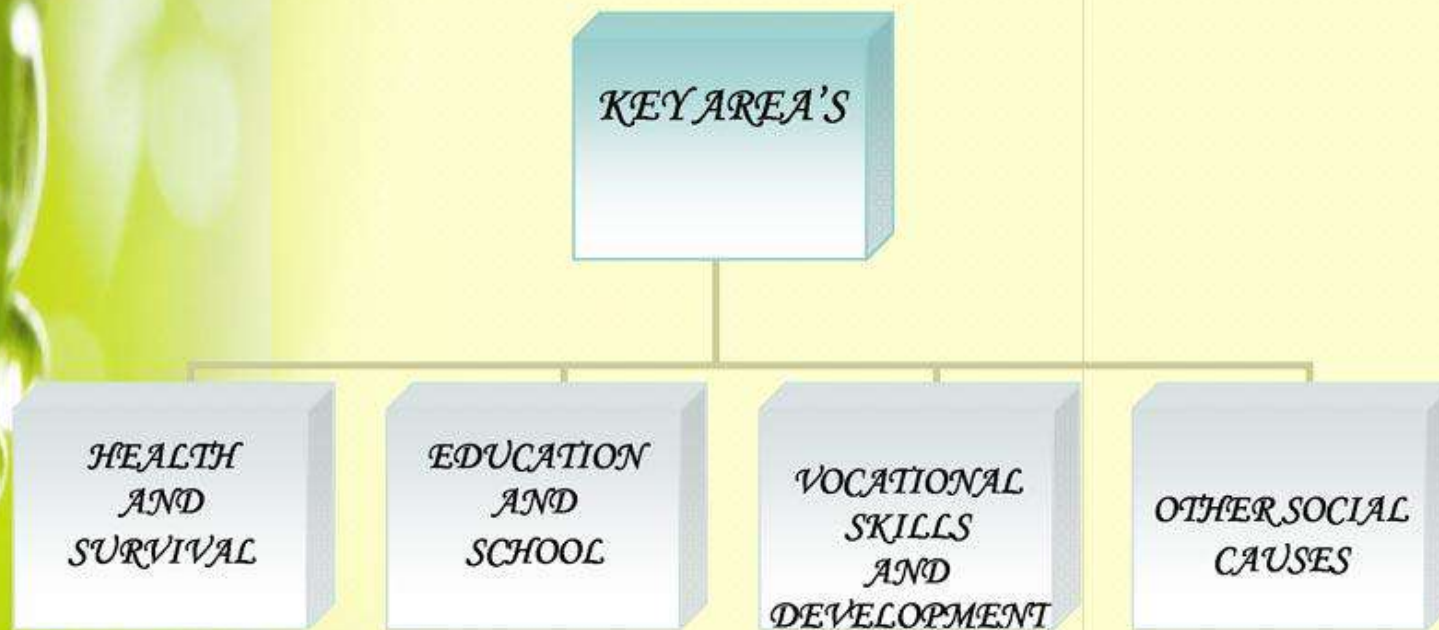

About Initiatives for 2011-2012

Being very first year of the establishment, our prime focus was to promote the organization and its vision & to attach the people with us to promote our initiatives we were going to launch. For this organization rapidly organized awareness programs for Education, Health, Skills Development and other social causes

Members, employees and volunteer are delivered their best and launch some projects too but lack of Tax exemption certificate and registration certificate from income department we were face quite tough time to manage funds for smooth implementation of our projects. But we have not good financial resources even when we people did not lose hope and keep on our initiatives and keep struggling to changing destitute lives.

In 2011-2012 we launce program and organized awareness events for our prime field Education & Schools, Health and Survival, Vocational Skills Development and Other Social Cause as described further

Initiatives for Education & Schools

To support others firstly PSF work to build its identity through organizing various activities among the students at Schools, Collages and Polytechnics, without association of general public a social organization cannot reach to its goal.

Initiatives for Health & Survival

Project: - HEARTENERGIZE

In June-2011, PSF launched its very first Project HEART ENERGIIZE. Each year about 150,000 babies are born with life-threatening Congenital Heart Defects which is the one of main leading cause of death in the first five years of life, which is often the result of poor environmental factors, poor diet & medication during pregnancy and delivery at home with un-hygienic medical tools & untrained midwifery.

Till March-2012, 6 children get support for implantation of Device Enclosure for Patent Ductus Arteriosus Defect or Ventricular Septal Defects. Treatment done at G.B Pant Hospital, New Delhi-110006



Activities for Health & Survival

- *PSf support Physiotherapy center located at Anandgram Kusth Rog Samiti, Tahirpur and provide Fridge , Washing Machine and Medicines required for daily basis treatment of wounds*



- *Jackets were distributed to residents of Satya Jeevan Leprosy Society, Shri Niwas Puri, Delhi in Dec -2011 to support survival during winter season*



- *Aids awareness program with Delhi Aids Control Society on organized at slum of East Delhi to cover weaker section of Delhi and teach how to avoid to get infected with HIV. After awareness session free Condoms were distributed*



Initiatives for Vocational Skills Development

We believe that for growth of nation, we need to bring changes to destitute for Academic level or Health conditions but education or health is not sufficient to feed a family without any specific skill quality. If we will not focus to provide skills development opportunities to destitute then our support for education or health will lost its value.

These days' private schools start to focus to give Computer Training along with education so the student will become skilled as well. But the students learning at Govt. School not getting this favor yet neither by the school not by the parents due to lack of financial resources.

Against the above backdrop, From January-2012 to March-2013 we supported computer training of needy students, pursuing their course at Lal Bahadur Shastri Institue, Sangam Vihar and Delhi. This was a three months course & in each batch 15 students enrolled by the institute.



Initiatives for Other Social Causes

PSF meticulously organized awareness campaigns to fight with social issues and make people aware about the organization, so that they can approach us to support their family member for Education, Health Problem etc. We focus to build strong bonding with destitute community to make them comfortable to come to us for the solution of their problem. Significant Accounting Policies and Notes to the Account

A. Significant Accounting Policies :

1. Basis of Accounting:

Financial Statements are prepared under the historical cost convention on the accounting principle of going concern and has followed the 'Mercantile System of Accounting' to recognize all the items of income & expenditure on accrual basis as and when due except member's annual contribution on cash basis.

2. Revenue Recognition :

Contributions, Donations, Program Registration Fees, Grants etc. have been recognized as income. Receipt from members as annual contribution, generation of fund, any activity specific contribution or specific contributions has been considered as contribution to capital fund.

3. Fixed Assets:

Fixed assets of the Forum have been taken at cost comprising its purchase price and any attributable cost of bringing the asset to its working condition for its intended use.

4. Depreciation:

Depreciation is required to be provided at the rates, as specified under Income Tax Act, 1961 for Written Down Value method (WDV). Further, the treatment of depreciation, on assets purchased from specific grants/funds under FCRA to be resorted to as per AS-12. However, no depreciation has yet been provided on the fixed assets.

5. Accounting Standards, issued by ICAI, as applicable to the operations of the Forum, are being followed.
