

EDUCATIONAL PROJECTS

Our Path to Progress:- Approx 500 children from leprosy families get Pre-Primary Education in School running by Parivartan Sandesh Foundation at Anandgram, Tahirpur, Seemapuri Delhi-110093 by the name of St Teresa Missionary School.

Project Duration:- April 2012- March 2015 with monthly cost of 300/child and this project was run with individual donations of regular donors.





Swachh Jal Apne Haath, Swachh Bhojan Apne Saath:-

Approx 150000 students from Govt and MCD schools located in slums get Tiffin Box and water bottle under project "Swachh Jal Apne Haath, Swachh Bhojan Apne Saath" to avoid use of news paper, plastic poly bags and consumption of unhygienic water of school tanks. Our utmost aim to implement this project is to provide resources to poor students to carry hygienic food and water to the school.



Project Duration: - April 2012 to 2016 and this project worked with individual donations only.



Our Path to Progress Part-2:-

Approx 200 children get pre-primary and coaching class upto 8th standard at PSF education center under project OUR PATH TO PROGRESS. Project is implemented at Yadav Nagar Slum of Navi Mumbai to facilitate the children of Migrant families with association of Aarambh.

Project Duration:- April 2014 to March 2016 with monthly cost of 700/-child









Our Path to Progress Part-3:-

Project launched in 2017 with objective to impart education to the children who are poor or from migrated families. Under this project, we are providing primary education and nutritious meal to 125 to 150 children every year Amrit Varsha school, Sector-6, Vasundhra.

Project still in force with cost of 300/student

HEALTH & SURVIVAL PROJECTS

Project Heart Energize: - This was the first Project after establishment in 2011, under this project, PSF support Heart Surgeries of poor children came to Delhi from all over India for treatment of congenital heart defects. PSF helped the families by deposit the device charges for surgeries and about 80 children get benefit from Heart Energize Program during 2011–2018.

In 2016 Fortis Foundation approach PSF to refer critical cases to Fortis Foundation and PSF deposit discounted charges for about 12 children's surgery at Fortis Hospital, Gurugram during 2016–2018.



Fighting with Early Puberty: -

PSF provided treatment for Central Precious Puberty disorder to 5 girls. These girls required monthly basis treatments to control the growth of hormones up to the age of 14 or 15. Dose Quantity varied depending upon their condition. We also consider the request of parents who do not wants to disclose their daughter's details.

Project Started: - April 2012- 2017 and this project was run with individual donations. Cost of each beneficiary is approx 15000/- quarterly





Support to Cancer Surgery:

Supporting monthly treatment of chemotherapy, radiation sittings & others of 5 children's suffering with Cancer with association of Mumbai based organization SUDHA.. PSF provide financial assistance for those families

Project Started: - April 2013 to March 2014, Support 5 children with Monthly cost of 10000/- of each beneficiary

Project Health for All: -

This Mobile Dispensary project was started in iApril-2013 with support of QUEST DIAGNOSTICS, with objective that not any poor person, whether it is a child, a teenager, an adult woman or a man or an elderly should not suffer with easily preventable disease & infections.

Under this project a Mobile Dispensary unit was started to provide free primary health check-up with medicines. The concept was designed to reach residents of East Delhi slums on alternate days. This van was consisting of a MBBS Doctor, A Nurse to facilitate poor people with check-up & free medicines.

This project helped about 42000 people get benefit of this project during 2013-2017.

Health Rainbow: -

In 2013–2015 PSF run this project to provide Vitamin–A & De-worming tablets to children at Delhi & NCR slums. This project was in association with Vitamin Angels, US based organization.

About 30000 children get benefit of this project.

Inderadhanaush Charitable Dispensary: -

This project started with association of Inderadhanush Charitable Dispensary, Nyay Khand, Vaishali, U.P to facilitate the poor people for health services. Under this project PSF provide free of cost medicine to & OPD charges for poor children, Females & Senior Citizen. Project started in April–2017 and every week about 50 patients get benefit of this project

From April-2017 to March-2018, every Monday PSF organized camp at dispensary to provide Hepetitis-A vaccination and in a year about 1350-1400 people get benefit from this camp.

This initiative was launched in 2018 with aim to support poor females through providing them free of cost Sanitary Napkins to prevent Urinary Tract Infections, Rashes in genitals, to ensure good reproductive health and to Minimize the due to use of unhygienic cloth & other materials during periods. Under project two distribution centers was opened to facilitates the beneficiaries one is at Okhla, Industrial Area, Delhi & another is at PSF office, Sector-61, Noida.

Project is still in-force & every month about 235 females collect free sanitary napkins







VOCATIONAL SKILLS DEVELOPMENT PROJECTS

"SAMARTH" Scholarship Program:-This project implemented to support poor students for Professional career oriented courses & providing financial assistance

to 5 girls for training of General Nurse Midwifery at various institutions.

Project Duration: - April 2012 to 2016, cost of 70000/-annually per beneficiary





Spreading Dignity:Parivartan Sandesh Foundation also providing financial help to needy students who are taking vocational courses at Lal Bahadur Shastri Institute, Sangam Vihar, New Delhi During April-2013

to March-2015 about 50 children get computer education with financial support of PSF

This project cost 600/- monthly for each student.





Saksham Naari, Sashakat Samaaj:-

To empower poor girls & ladies with tailoring skills at stitching learning centre to make poor girls and women self dependent & to give a chance to live with dignity. After training PSF provide sewing machine to deserving candidates to start work from home and help to get job in any garment export company which makes them capable to support their own family too. Every year about 200 girls get benefit with this project

Project Duration: - April-2013 to 2018 with monthly cost of 1000/-beneficiary



Spreading Dignity Part-II:-

Approx 100 girls and boys get Communication Skills Development at PSF training centers under project PREADING DIGNITY located in slums or destitute areas with monthly stipend. To empower them with chances to get job in hindi call centers. Parivartan Sandesh Foundation also support deserving candidates for job placement after successful training about 100 candidates are successfully working at hindi call centers

Project Duration:- April 2014 to 2016 with monthly cost of 5000/-beneficiary



SOCIAL CAMPAIGNS

Eat Healthy, Live Healthy:-

Is one of the most important saying for healthier life. Under this campaign volunteers organize events at Schools, Markets, Shopping Malls and distribute pamphlet, to aware the children and youngsters about bad effects of "Junk Food Items" & good values of nutritious food.

Project Duration:- April 2012 to 2014 with monthly budget of 20000/-





Sanitation Campaign:-

In 2014 under this campaign PSF build 3 toilets in the campus of Anand Gram Leprosy Colonies to prevent infections due to poor hygiene in leprosy colonies. Each bathroom cost about 35000/-

"CHILD IS THE FATHER OF MAN" the famous lines by William Wordworth. It symbolizes the need of children in building a healthy nation and society. With this in mind PSF launch this campaign and under this campaighn volunteers organized various awareness events at posh residential societies, Branded Shopping Malls, Corporate companies to aquire maximum of high profile people to urge them to not take any services from children below the age of 14 & to inform the legal authorities if any children seems indulge in "CHILD LABOR" at their surroundings.

Project Duration:- April 2014 to 2016 with monthly budget of 20000/-



COVID-19 RELIEFWORK



CAPACITY BUILDING OF THE TEAM

Acknowledging that the support team was to be mentally, emotionally, and logistically prepared to handle the situation, various measures were taken on dayto-day basis, the project teams would discuss their anxieties, fears, and the situation on-ground which they got to know while working. Alongside discussing the problems, potential short-term immediate solutions were collectively devised by the team, through which all members got an opportunity to innovate and propose ideas for larger action.

about "staying inside" to stay safe had a difficult connotation. At such a time, team PSF exhibited immense commitment towards society following the motto that team

PSF never backs down from a challenge, COVID times were no exception.

Upon finding out the grim situation due to COVID outbreak in the communities, various relief measures were undertaken by our team with utmost care, courage, sincerity, and compassion to distribute ration, education and recreation material, sanitary napkins for girls, health and hygiene kits, mobile phone recharges and woolen clothesduring winters. For the security of our team members, 367 PPE kits were distributed so that they can work on the field smoothly

With the closure of schools, the education of children suffered a lot. For a smooth continuation of the studies, beneficiaries were given 6254 stationery kits which contained notebooks, pencils, pens, coloring books, crayons, sketch pens, etc. It had also become important to take utmost care of our mental health.

We distributed 6254 play items to the beneficiary which included ludo, skipping ropes, balls for their recreational activities. Additionally, to maintain hygiene in their surroundings, 6350 health and hygiene kits included soap, toothpaste, toothbrush, sanitizers, and mask were distributed to beneficiaries.

To provide warmth in the extreme winters, 5000 people get Blankets with association of Hamdard & 1500 children get woolen clothes like jackets, body warmers, socks to protect themselves from the acute winters during shivering monthsof December and January.

Under Project PSF- Sakhi 3 Sanitary napkins distribution centers was opened at Delhi & NCR to facilitate poor girls & ladies with free sanitary napkins on monthly basis. About 7800 packets was delivered during 2020-2021. The girls were educated to practice safe and hygienic menses to eradicate the problems which occur by using cloth.

The technological up-gradation in the field of education is a breakthrough. Working closely with the street-connected children it was a major challenge to connect with them through online mode as many of them lack internet access. To impart education to children without any hindrance, 408 children's mobile phones were recharged.

Keeping in mind the need of the hour, variousvideos on COVID-19awareness (including basic information about the virus, its spread, and keeping safe) were prepared and shared with community members and children. The material for children was prepared keeping in mind their ability to absorb the information-thereby using child-friendly depiction of the virus.

During the lockdown, immediate needs of the people who lost their job & facing financial crisis were catered through distribution of dry ration kits, hygiene kits (comprising masks, toothbrushes, toothpaste, nail cutters), and stationery kits at Delhi & NCR. All distribution drives took place with the support of local public-serving authorities, ensuring compliance of COVID safety protocol.









SIGNIFICANT ACCOUNTING POLICIES & NOTES TO ACCOUNTS

A. SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Preparation of Accounts.

From April-2016 to Dec-2019 every month about 5000 people get benefit of this project with cost of Rs 8/- per meal Due to covid-19 this project is temporarily on hold



WORLD WILD FEDERATION

Need of humanity is not restricted to Humans only but also many animals who are living with us in this world are looking for help from us. PSF registered a project WORLD WIDE FEDERATION (WWF) to help stray animals and launch initiatives like:-

- To tie reflecting neck collars to stray dogs and cattle so that drivers can recognize their presence on roads from a convenient gape to prevent the accidents. This will also decrease the mortality rate of stray animals due to accidents. Our volunteers tie reflecting collars to 1500 stray dogs & 200 Cattle.
- Initiative is to vaccinate the stray animals with Anti Rabies Vaccination so that they can leave in residential areas, and residents can feed or care for them without any fear.
- Over 300 dogs were sterilized so far at different residential areas or residential societies at Delhi & NCR. These achievements and many more were only possible with the support of our honorable donors, without whom nothing could be done to help these animals in need.
- Initiative to help survival during Covid Pandemic WWF Team members was took care of 325 dogs living nearby their homes and daily provides them Food & Milk and needed medication (if required).
